GUN CASE FITTING INSTRUCTIONS:

To order a custom made gun case made from your game skins, we will need to know the overall length, whether it is to be used for a scoped rifle or shot-gun, (if scoped rifle, we will need the measurement from the highest point of the scope to the bottom of the trigger guard). For handgun cases we will need the model number and caliber of the handgun plus the overall length. If the handgun is scoped we will also need the overall measurements described above for rifles. Once we receive your measurements we will consult with our craftsmen and provide you with a price.
